

# INFORMED CONSENT FORM PROCESSING PERSONAL DATA OF EUROPEAN UNION (EU) / EUROPEAN ECONOMIC AREA-BASED (EEA) PERSONS

This consent form provides information for Green Contest participants to understand how the processing of their personal data will be conducted for the purpose of SKILLBILL project, which is subject to the General Data Protection Regulation (GDPR).

Please sign at the bottom to indicate that you have read and understood how personal data will be processed, the related rights, and that you consent to this processing as described below. According to Article 8 of European GDPR, the signer of this document is the participating student if he/she is at least 16 years old, otherwise the adult holder of parental responsibility over the child if he/she is below the age of 16 years.

#### PERSONAL DATA REQUIRED

In addition to the information and material (video, essay, comic strip, photographs, podcast or 3D plastic) you will directly submit to us, these are the categories of personal data of participating students that we will use:

- Generic data (in particular Name, Surname, age, country, school of origin);
- Email and telephone number;
- Pictures and videos while working for the project.

For authorization reasons, the Identification Document (ID) of the person signing this informed consent form is required.

The personal data of students will be processed for the following purposes:

- Managing contest registrations;
- Communicating and contacting participants;
- Evaluating contributions and determining winners;
- Publishing results and awarding prizes;
- Complying with legal and regulatory obligations.

#### YOUR RIGHTS

Under the GDPR and its implementing laws at national level, you have the following rights, with the conditions and limitations set out in Chapter III of the GDPR:

- To obtain confirmation that your data/your child's data is being processed, as well as access to and a copy of your personal data/your child's data;
- To obtain correction of your personal data/your child's data;
- To obtain erasure of your data/your child's data, if you submit a reasoned request;
- To obtain portability of your data/your child's data;
- To obtain restriction of your data/your child's data (which means we limit the access to your dataset) if you submit a reasoned request;
- To withdraw your consent at any time.

When you withdraw your consent, we will not collect additional information related to you/your child, but the withdrawal is NOT retroactive and you/your child can no longer participate in the Green Contest.

To exercise your rights, please use the contact information below to submit a request. When you submit a request, please indicate your name/your child's name, the name of this project, your reasons for making the request, if necessary, and other details you think will be useful for us to comply with your request.

#### ADDITIONAL INFORMATION

If images of underage students are used, the only recognizable ones must be members of the participating group and for documentary purposes. As far as possible, the SKILLBILL committee will conduct checks before any publication, but the participants will still be responsible in case of errors or violations reported by third parties.

We retain your personal data/your child's data for 5 years after the end of the Project foreseen in September 2025. If you have any concerns about how your personal data/your child's data is being handled, contact SKILLBILL project leader:
